The submission you are about to experience arises from: - **The Commission of Inquiry Into Administrative Irregularities in the System of Justice and Activities by Members of Secret Societies.**

The late Judge Hassan Mall of the Truth and Reconciliation Commission granted the abovementioned commission following an application to the High Court of Durban brought in person by Izak Labuschagne in May 1995. The Commission is the first *actio popularis* i.e., **Peoples Commission** under Section 38 of the **New Constitution of South Africa** and Izak currently serves as the **Chief Investigating Officer** of the Commission. Izak has served as non-affiliated **Guardian Committee Member** and **Legal Advisor** for the **African Christian Democratic Party** and he has **intervened in the public interest** in several prominent political and religious cases in South Africa. Izak has acted as **Strategic Planner** for several projects in the SADEC region reported to the **Australian High Commission** in respect of projects in Swaziland.

Through the Commission Izak has gained a vast knowledge of **secret and not so secret societies, Biblical and Secular law**, together with the ***ins and outs of the International Political, Business and Ecclesiastical world.***
