PETITION / MANDATE

- A. I have become aware that **the Constitutional Court upheld a ruling that precludes the recognition of the Bible as part of a church's law.**<sup>1</sup>
1. I can never allow the state to dictate my beliefs to me, or to those I associate with in order to worship my God.
  2. Accordingly, I hereby mandate the Joint Houses of Assembly to install legislation that will immediately and permanently preclude any person or organ of state from imposing their own beliefs, and opinions on me or any association of persons.
- B. I know that the Constitution of this nation states that **no legislation can preclude the recognition of a system of personal or family law adhered to by persons professing a particular religion** in section 15(3)(a) <sup>2</sup>
1. I find it very disturbing that the highest judges in this country, have exalted themselves above the laws of the land, in this ruling.
- C. I am also aware that there was no hearing, no reasons are given for the judgement, **gross administrative irregularities** have been condoned in our system of justice at the highest level and that the **identities of the judges responsible for this are being kept a secret**.
1. Accordingly I also mandate the Joint houses of Assembly to immediately have the judges responsible for this **infringement of the democratic rights of the masses removed from office**<sup>3</sup> in the interest of restoring democracy to our country<sup>3</sup>



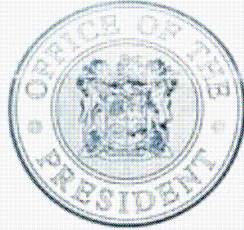

We would accordingly advise that you communicate directly with the Judicial Service Commission on this matter.

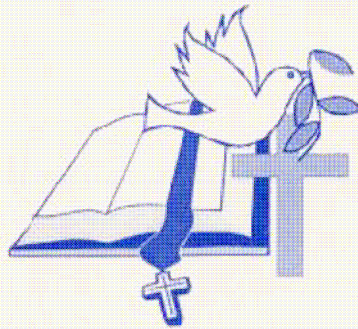

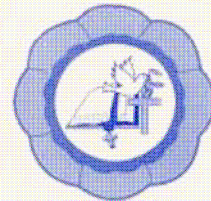
