Dear Brother



Mr Labushagne is authorised to open up a banking account under the name Christian Coalition- Legal

Subject to the following:

- 1) Two signatures required on all payments.
- 2) Monthly accounts relating to income and expenditure to be provided to the national executive for audit purposes by the first week in every month.
- 3) Budgets are to be submitted for approval by the national executive.
- 4) Mr Labushagne will be responsible for his own fund raising.
- 5) No debts may be incurred.
- 6) Subject to the constitution of the Christian Coalition.
