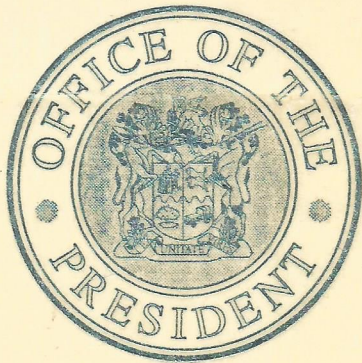

Since the subject of your correspondence falls within the portfolio of the Minister of Justice the President has requested that it be referred to him.

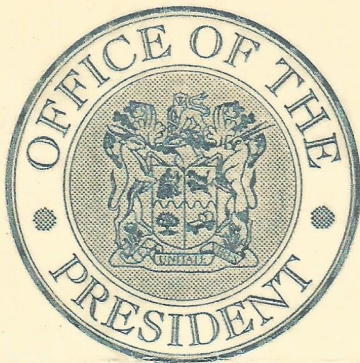

**ST JOHN'S APOSTOLIC FAITH MISSION CHURCH AND REQUEST
FOR SUSPENSION OF JUDGES IN TERMS OF SECTION 104(4) AND 5
OF THE INTERIM CONSTITUTION, 1993**


By direction of Mr A M Omar MP, Minister of Justice, I acknowledge receipt of your letter dated 31 January 1997. The Minister has noted the contents and has requested me to respond as follows:

It is not clear on what basis you want the Minister to bring the judgment by Puckrin A J under review. As you are aware the courts are independent and as such only subject to the Constitution and the law. No persons or organ of state may interfere with the functioning of the courts. If you are of the opinion that the judgment given by Judge Puckrin in the relevant case was not in accordance with the law you should encourage the relevant party to take the matter on appeal to a court of higher jurisdiction. If the relevant party cannot afford to appeal from a financial point of view the legal aid services rendered by the Legal Aid Board and which may be available may be utilised for this purpose. Alternatively, other bodies rendering legal aid services such as the Lawyers for Human Rights, the Legal Resources Centre and the Legal Aid Clinics may be approached for possible

assistance.

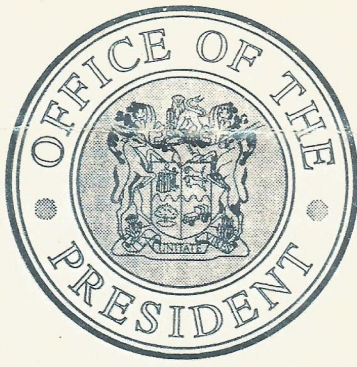
Regarding the removal or suspension of Judges in office your attention is directed to section 177 of the Constitution of the Republic of South Africa, 1996. In terms thereof a Judge can only be removed from office or suspended on the advice of the Judicial Service Commission. Since you have addressed a copy of your representations to the Chairperson of the Commission, it is expected that your request for the suspension of the Judges concerned will be placed before the Commission for consideration.

REQUEST FOR SUSPENSION OF JUDGE(S)

I acknowledge receipt of your letter dated 2 September 1997 addressed to the President regarding the above, the contents of which have been noted.

As you are aware, the President may in terms of section 177(3) of the Constitution of the Republic of South Africa, 1996 (Act No 108 of 1996) only suspend a judge who is *inter alia* found to be suffering from an incapacity, is grossly incompetent or is guilty of gross misconduct on the advice of the Judicial Service Commission.

We would accordingly advise that you communicate directly with the Judicial Service Commission on this matter.
