## Copied text of e-mail sent to Argus Group and Freek Robinson of the SABC's program called FOKUS

Notwithstanding the e-mail sent below, both groups failed to report the true facts.

The latest correspondence to the President and the Deputy Minister of Land Affairs Prof. Dirk du Toit is attached.

The latest development is that the Land Bank are now trying to obtain control of the land based on an illegal lease that was installed. The local council also want the

same land and they deny ever having entered into such lease (I have one of the original copy's of the lease and so has the Land Bank). The Nth Cape Government are sending one Mothibi to Goodhouse tomorrow but they were again careful to exclude me as the advisor of the land occupant's from the talks. They apparently want to discuss a new project run by them with the occupants of the land. His brother Piet Cloete will confirm that they no longer can afford to trust government or the legal system when it comes to projects in the area.

That indeed, is the status quo in several other areas in South Africa, Giyani, Rust de Winter, Makhathini Flats (KZN) where the occupants have given me mandates for projects but on the express understanding that government is not to be involved. The government refuses to let these people develop because they refuse to loose the opportunities to manipulate the populous (and with that the vote) in these areas.

You will in all probability need to spend more time viewing the quite shocking collection of evidence being collated for a book to be published (by invitation) in the USA.

Please note that I have just been advised that NI have propagated a highly defamatory report on me to the government and media. I am looking for someone who has the integrity to tell me what is in that report so that I can take the necessary action. They obviously want to discredit the one source that can expose the whole debacle.
